Friends:

It has been a distinct privilege and a high honor to lead Thomas Nelson Community College the past three years. Let me hasten to note that I consider my tenure here albeit brief, a milestone in my career. There are many persons too numerous to mention to whom I am grateful for affording me the opportunity and for supporting my efforts along the way. 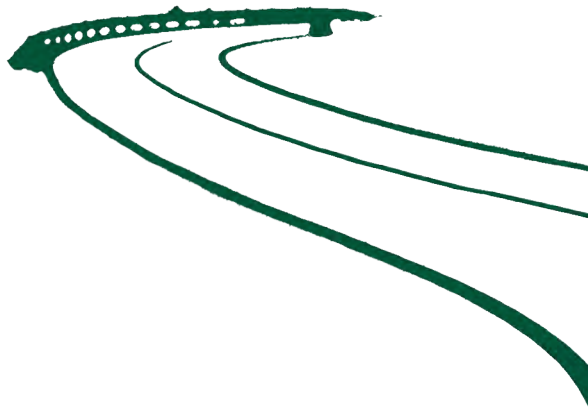

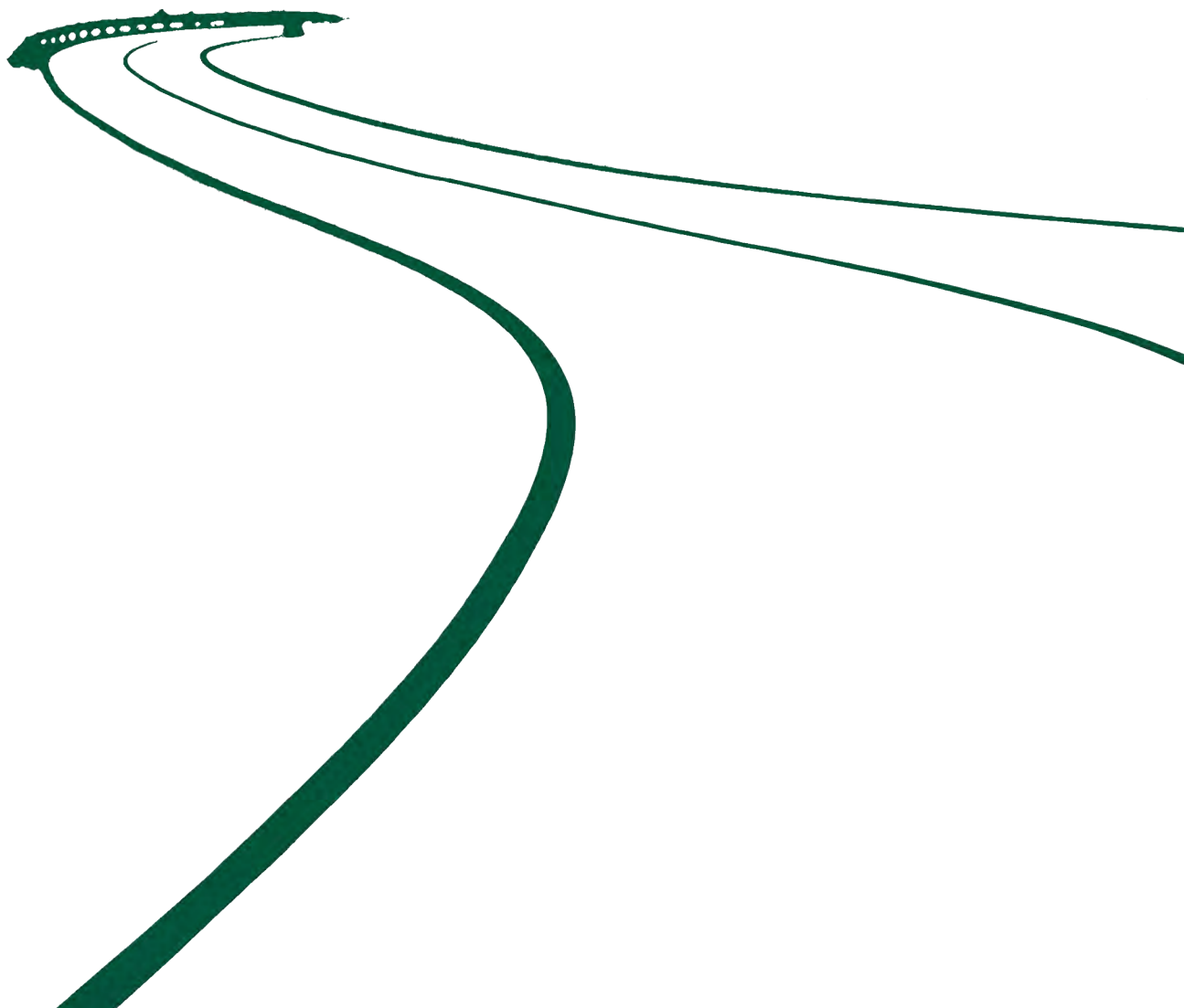

## Library Provided Free Online Language Learning Tool

Thomas Nelson Community College libraries began offering a free online language learning tool that covers over 20 foreign languages and more than 10 English as a Second Language (ESL) courses. Available to all TNCC students, faculty and staff, the Mango Languages program provides interactive lessons that combine real-life situations and audio from native speakers.



## Iron Street Productions Presented 'Deathtrap' at TNCC

Iron Street Productions presented Ira Levin's "Deathtrap" in March 2010 in the Dr. Mary T. Christian Auditorium, Hampton campus. In this suspenseful two-act play, playwright Sidney Bruhl is fueled by the desire to once again be the toast of Broadway.

## Engineering Student Participated in NASA Scholars Program

Mechanical Engineering student Trevor Jackson enhanced his classroom studies with hands-on experience during NASA's National Community College Aerospace Scholars program in October 2010 at Johnson Space Center in Houston, Texas. Jackson was among 90 students chosen from community colleges in 23 states to participate in the pilot program. The students were chosen based on their performance in a NASA web-based summer program that explored topics in Engineering and Technology. During the three-day program, Jackson worked alongside NASA experts in the engineering design and production of robotic explorers and joined other students to establish a mock Mars exploration company.

## National Dance Company Featured Bollywood and Kathak at TNCC

Nepal Dance School presented Bollywood and Kathak dance in November 2010 in the Dr. Mary T. Christian Auditorium, Templin Hall, Hampton campus. Based in Washington, D.C., the Nepal Dance School uses dance and music instruction and performances to promote cultural enrichment and diversity. The performers entertained and educated audiences with Bollywood, which features a mix of folk and classical Indian choreography, and Kathak, one of the eight major classical dances in India.

## Faculty Colloquium Explored Sci-fi

Science fiction and fantasy enthusiasts enjoyed a Faculty Colloquium titled "Old Ideas for New Worlds: Science Fiction, Fantasy and Archetype." TNCC English faculty Jacqueline Blackwell, Alex Chirila, Lisa Ray and Michael Weiser explored a few of the most common central themes in science fiction and fantasy genres.

## New Psychology Course Explored Similarities, Differences between Men and Women

Thomas Nelson Community College facilitated in-depth conversations about the disparities between men and women and uncovered the similarities in PSY 265: The Psychology of Men and Women. The new three-credit course became available in spring 2011 as an elective for students who completed PSY 200: Principles of Psychology.

## Eastern Shore Community College President Addressed AAWCC Audience

Eastern Shore Community College President Dr. Linda Thomas-Glover shared her observations on "Women at the Helm: Let's Talk Turkey" during an American Association for Women in Community Colleges (AAWCC) luncheon at TNCC. The organization's Hampton Roads Chapter co-sponsored this "Lunch with a Lady Leader" event with the Tidewater Regional Center for Teaching Excellence.

## Local Drummer Brought High-Energy Rhythms to TNCC

Local drummer Connie Ralston entertained students, faculty and staff with a rousing performance during World Rhythms at TNCC's Historic Triangle campus in Williamsburg. For more than 15 years, she has conducted workshops for children, adults, at-risk students and others. Ralston also performs with Beleza, a local women's drumming group.

## PTK Hosted Free Sessions on Cyber Bullying

Thomas Nelson Community College's Phi Sigma chapter of Phi Theta Kappa (PTK) International Honor Society presented two informational sessions about cyber bullying. Anton Bell of the Commonwealth Attorney's Office was among guest presenters. The seminars were part of the chapter's participation in PTK's honors study topic, "The Democratization of Information: Power, Peril and Promise" and covered areas such as current federal and state laws, psychological impacts on victims of cyber bullying and how to recognize cyber bullying.

## Student Group Assisted Community Job Seekers

The Students in Free Enterprise (SIFE) team helped local job seekers with its "Dress for Success" event at the Peninsula Workforce Development Center. The organization provided community members with attire suitable for job interviews and work-related endeavors. SIFE is an international non-profit organization that works with leaders in business and higher education to mobilize college students to make a difference in their communities while developing the skills to become socially responsible business leaders.

## Virginia Secretary of Education Touted STEM Initiatives During Visit

Virginia Secretary of Education Gerard Robinson presented a Science, Technology, Engineering and Math (STEM) education update at Thomas Nelson Community College to garner support for Governor Bob McDonnell's STEM initiatives. The initiatives promote the seamless integration of STEM subjects throughout K-12 curricula in every Virginia school not just magnet or specialty schools, or private and public academic institutions.



## New Degree Programs Prepared Students for Careers in Information Technology and Human Services

Two new degree programs joined TNCC's offerings for spring 2011. The programs give students academic credentials for careers in fields such as computer science, information systems management, mental healthcare, social work and more.

The Associate in Science in Information Technology program prepares students for transfer to four-year colleges and universities and provides training in all aspects of managing and processing information and related technologies. The Associate in Applied Science in Human Services trains students in ethical practices, communication skills as well as crisis prevention, intervention and resolution.

## Oceanography Course Added to Science Offerings

Thomas Nelson Community College expanded its offerings to include Oceanography I and Oceanography II. The new four-credit, two-semester course enhances the College's STEM curriculum by giving students another option for completing laboratory science degree requirements while enhancing both local and global ocean literacy.

## TNCC Offered Wetlands Field Study Course for Community at Large

Thomas Nelson Community College provided an opportunity for in-depth wetlands study through a two-week course offered by the Biology Department. Called Topics in Wetlands Biology (BIO 295), the three-credit course ran in August 2010.

## Middle College Expanded to Williamsburg

Workforce Development expanded its Middle College program in Williamsburg. The free program prepares young adults ages 18-24 for in-demand careers as they earn their GED. At TNCC's Historic Triangle campus, available training includes Nurse Aide, Welding, HVAC, Medical Coding & Billing, Automotive and more.

## Future Hampton Teachers Graduated from TNCC Through School District's 'Grow Your Own' Initiative

Nearly 30 aspiring teachers graduated from Thomas Nelson Community College as part of a program called First Steps, a creative "grow your own" initiative by Hampton City Schools (HCS) to address a shortage of elementary and special education teachers. The students, all full-time HCS employees, met requirements to earn Associate degrees in Social Science with specialization in Education and transferred to Old Dominion University for the program's next phase.

## Geology Department Head Received Grant to Enhance Summer Field Study Course

Peter Berquist, Geology Instructor and Department Head, received a Dorothy Stout Professional Development Grant from the National Association for Geoscience Teachers. The \$750 grant helped support a summer field course in Montana's Northern Rocky Mountains. For the third consecutive year, Berquist and an assistant professor from Northern Virginia Community College facilitated the two-week course.



## Performing Arts Department Presented Frankenstein Drama

Thomas Nelson Community College's Department of Performing Arts presented "Frankenstein – A Radio Drama" in the Dr. Mary T. Christian Auditorium on the Hampton campus. Produced by special arrangement with the Dramatic Publishing Company of Woodstock, Illinois, the project was made possible with the support of the TNCC Educational Foundation, The City of Hampton, Hampton Arts Commission, The City of Newport News and the Newport News Arts Commission.

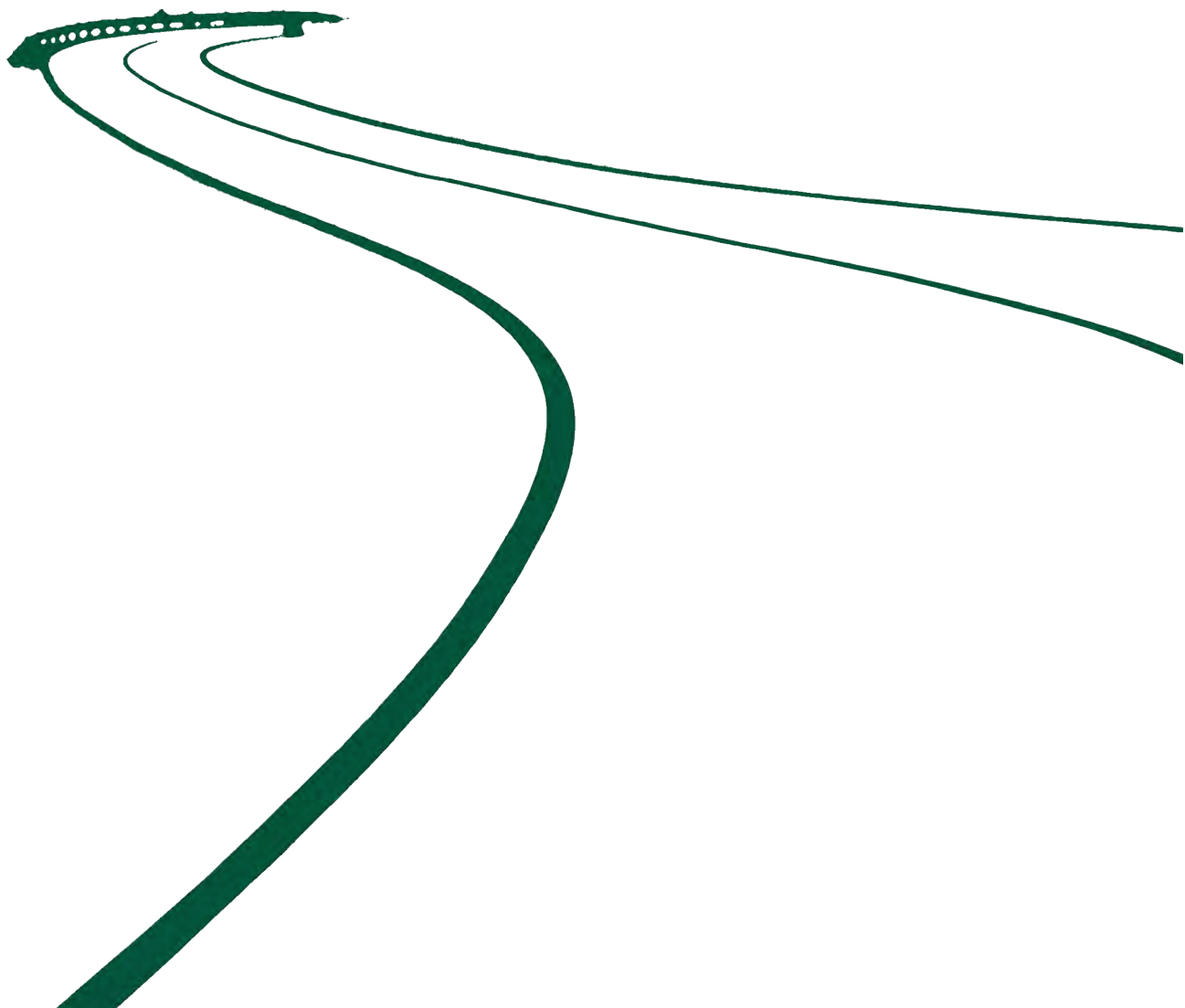
## Institute for Diversity and Inclusion Launched

In collaboration with the Hampton Citizens' Unity Commission, Thomas Nelson Community College launched the Institute for Diversity and Inclusion in 2010. Open to all TNCC personnel, the six-week interactive course takes place in fall and spring concentrating on diversity in the contemporary workplace and community. ## Workforce Development Held WTCE Graduation

Workforce Training and Continuing Education (WTCE) celebrated the accomplishments of over 60 students last August during its annual graduation ceremony at the Peninsula Workforce Development Center. The graduating class included the first students to complete the Contract Management and Information Security programs. The new programs train workers for in-demand jobs. In addition, this class included the largest number of Pharmacy Technician Program and Medical Coding & Billing Specialist Program graduates to date.



## TNCC Named Military Friendly School by 'G.I. Jobs'

Thomas Nelson Community College was listed among G.I. Jobs magazine's Military Friendly Schools for 2011. The list recognized the top 15 percent of colleges, universities, community colleges and trade schools nationwide doing the most to embrace America's service members (active-duty and veterans) as students. More than 15,500 students were enrolled at TNCC last year and of that figure, 1,300 were active-duty or veteran students.

G.I. Jobs provides service members and veterans with information about education, transition assistance and job opportunities. TNCC and others on the publication's Military Friendly Schools list were also acknowledged for offering additional benefits to student Veterans such as on-campus veterans programs, credit for service, military spouse programs and more.

## TRiO's 'Smart Start to TNCC' Attracted 21 Students

Twenty-one high school graduates enrolled at Thomas Nelson Community College for fall semester participated in the TRiO program's Smart Start to TNCC. The program caters to first-time freshman with cohort learning groups, mentors, learning coaches and more. Orientation activities for Smart Start ran July 26-30 having 100 percent attendance the entire week.

## College Launched Enrollment Re-engineering Project

As part of its strategic plan, "2010-2015 Shaping the Future," Thomas Nelson Community College undertook an Enrollment Re-engineering Project to enhance the enrollment process for prospective and continuing students and more effectively meet students' needs. In fall 2009, a Re-engineering Task Force finalized plans for reconstruction, reorganization and implementation of new strategies to improve student access and service. The project focused on the broad goals:

- Establish an inter-college online posting of the TNCC enrollment process for each type of student that seeks admission;
- Re-organize the Admissions, Registration and Records departments into a blended Enrollment Services unit where personnel are cross-trained to more efficiently meet student enrollment needs;
- Change vital technology capabilities to facilitate students' ability to utilize self-service options of the College;
- Enhance facilities by creating a Welcome Center designed to support student self-service and a Counseling and Advising Center designed to streamline student support services; and
- Institute an Information Center to assist students with online services and provide extensive information related to student support services and student activities.

## Workforce Development Launched New Accelerated Nurse Aide Program in Williamsburg

Workforce Development launched a new program to benefit Peninsula job seekers and employers in the medical field. Expanding its accelerated health care training, Workforce Development began offering the two-month Nurse Aide program in Williamsburg in January 2011. The new program addresses the needs of Peninsula businesses facing a growing shortage in hospitals, nursing homes and long-term care facilities. In addition to classroom instruction, students obtain practical experience at Williamsburg Landing, an assisted and acute-care facility in Williamsburg.

The first class of Nurse Aide program students graduated in March. Adding to the celebration, all of the graduates had received job offers before graduation day. Additionally, several healthcare employers attended the graduation ceremony to present other opportunities.



## Workforce Development Hosted Regional Rapid Response Summit

Thomas Nelson Community College Workforce Development, as the lead Rapid Response agency for one-fourth of Virginia, was host to a Multi-Regional Rapid Response Summit at the Peninsula Workforce Development Center in November.

## TNCC Instructor Joined Committee to Create Professional Organization for Geoscience Educators

Adjunct Geology Instructor Lynsey LeMay was among 10 Geoscience educators on a committee to establish a professional organization for Geoscience instructors at two-year colleges. The new organization will be affiliated with the National Association of Geoscience Teachers, a group created to enhance formal and informal earth science education for K-12 students and college students.

## Skills Certification Center Showed 44 Percent Increase in Demand

Thomas Nelson Community College's Skills Certification Center, located in the Peninsula Workforce Development Center, continued to grow and change to meet the needs of businesses, government agencies and the community. Last year, the Center administered over 1,130 certification tests, an increase of 44 percent from the previous year.



## Students' Work at Center of Multimedia Art Exhibit

Computer Arts students presented their work in "Identity Crisis" in Templin Hall on the Hampton campus. The exhibit included video, photography, hand-made books, drawings and other multimedia.

## Workforce Development Joined On-the-Job-Training Reemployment Project

Thomas Nelson Community College Workforce Development participated in a regional pilot project aimed at placing dislocated workers in advanced manufacturing jobs. Peninsula Worklink, the One Stop Center on the Peninsula, received a grant from Virginia's Community Colleges and the Peninsula Council for Workforce Development to implement the On-the-Job-Training Reemployment Project. Workforce Development provides training for candidates seeking welding and computer numerical control machining training, coaches them and refers them to prospective employers.

## Series Examining Leadership Featured TNCC President

President Alvin J. Schexnider was among government, business and education professionals from throughout the region who served as panelists for a Cox Business Executive Discussion Series titled "Leadership in Tough Times."

## TNCC Choir Presented Spring Concert

Thomas Nelson Community College's concert choir presented a spring concert in the Dr. Mary T. Christian Auditorium, Templin Hall, Hampton campus. The free performance was made possible with the support of the TNCC Educational Foundation, The City of Hampton, Hampton Arts Commission, Newport News Arts Commission and the City of Newport News.



## Dental Hygiene Program Offered Free Screenings

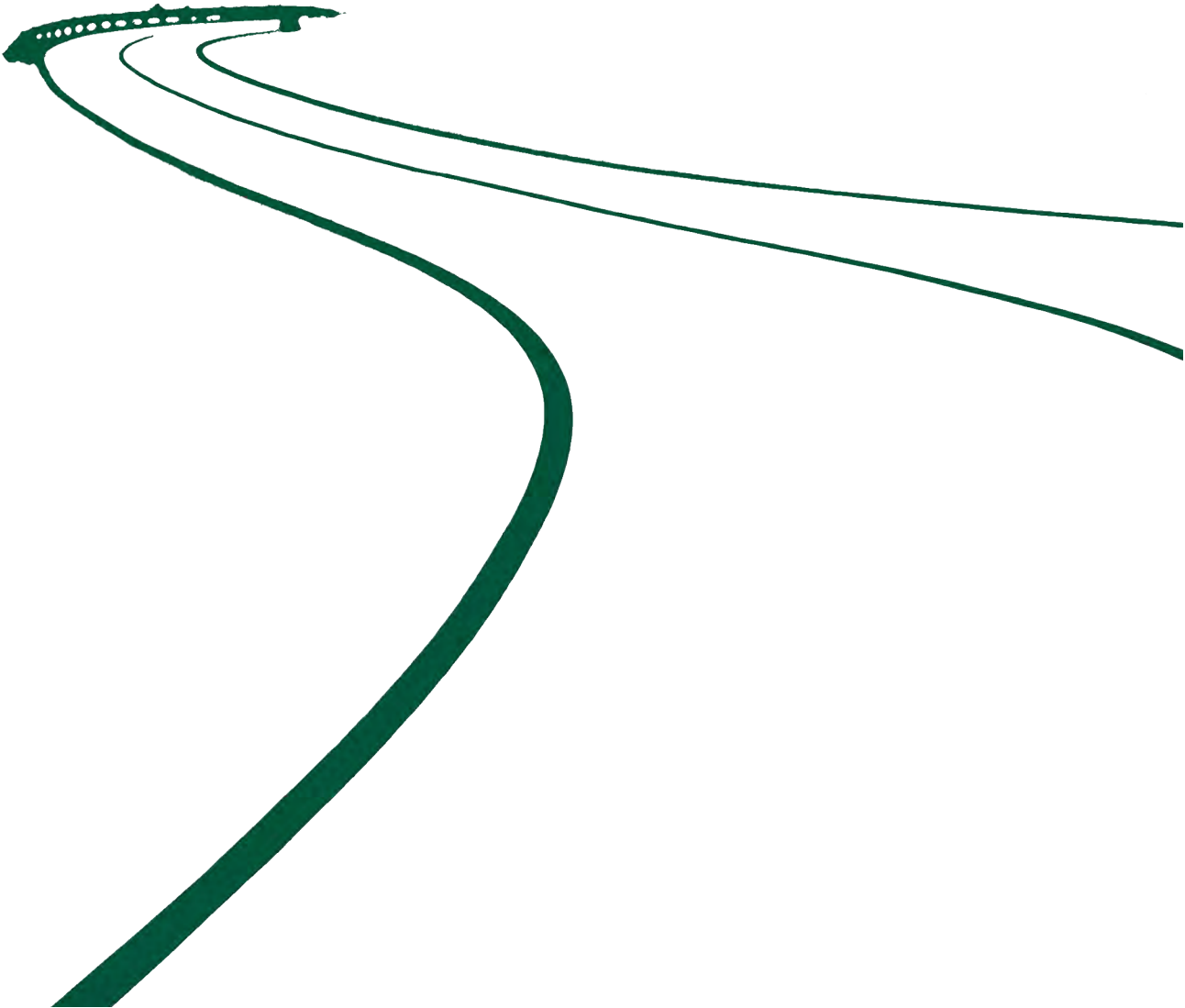
In acknowledgment of Valentine's Day, the Dental Hygiene Program held a "Healthy Smiles" event at the Historic Triangle campus providing free dental screenings and x-rays to students, faculty and staff.

Through the Dental Hygiene Program, TNCC trains students to provide a variety of oral health services under the supervision of expert faculty. The state-of-the-art Dental Hygiene Clinic enables students to provide quality patient care with focus on prevention and control of oral diseases. The clinic offers a range of services such as dental sealants; fluoride therapy; full-mouth radiologic series; oral cancer screening, dental and periodontal charting; extrinsic stain removal and denture/partial cleaning.

Art Instructor Jackie Merritt was among Peninsula area recipients of the 2010 Alli Awards. Presented in November by the Cultural Alliance of Greater Hampton Roads at The American Theatre in Hampton, the annual award honors individuals, businesses and media companies that have made noteworthy contributions to the region's arts and culture.

## Former Williamsburg Mayor Jeanne Zeidler Received College's Fifth Presidential Leadership Award

## AAWCC Awarded \$500 Scholarship to TNCC Student

The chapter was recognized for its workshops on cyber bullying placing second among chapters worldwide in the "Distinguished Issue Award Honors In Action 2011 – Technology" category. PTK presented only three awards in the category. Phi Sigma was also one of 50 chapters worldwide acknowledged in the Distinguished Honors in Action Project field.

## Two Students Earned High Academic Honors

## Dominion Foundation Grants Enhanced New Engineering Course

Students enrolled in "Topics in Energy Technology: Wind Turbine Blade Development and Testing," completed several groundbreaking studies during the spring semester. Funded by a \$10,000 grant from the Dominion Foundation, the new elective course explores wind turbine technology and design. TNCC was one of four Virginia colleges to receive funding from the philanthropic arm of Dominion Resources to support programs in skilled craft, engineering, environmental and technical studies, business, and student-led conservation programs. TNCC received an additional \$2,500 from the organization in February to purchase a Skystream 3.7 Marine Cutaway wind turbine demonstrator.
