C. Report from the College Board Liaison to the Thomas Nelson Educational Foundation Board of Directors

Mr. Allan Melton reported that he attended an Educational Foundation Board meeting on December 15, 2022. During the board meeting Mr. Todd Estes shared information about the Skilled Trades Center located in Toano, Dr. Porter Brannon informed the Foundation Board that enrollment in all sectors of the College had increased and announcements of reappointments to the board were made. Mr. Charles Southall will be the Educational Foundation Board chair and the outgoing chair was recognized for the years of service.

D. PRESIDENTS REPORT

a. Annual Workforce Development Report

Dr. Brannon reported that Mr. Todd Estes is now officially serving in the role as the Vice President for Workforce Innovation. Mr. Estes provided an overview of the annual workforce Development Report and emphasized the effort around the skilled trades, HR Strong and the Skilled Trades Center located in Toano.

b. College Reorganization Updates

The College has been undergoing a reorganization effort and Dr. Brannon reported that the restructuring has resulted in the merger of four smaller departments into one large division. The new division will be named Institutional Effectiveness and Transformation and this has resulted in the elimination of the position of Vice President for Institutional Advancement. Dr. Brannon recognized Ms. Cyndie Callaway for her time, talent and energy given in service to the college for the past 17 years. Ms. Callaway thanked the college board for their service and support over the years.

c. Written President's Report to the College Board

The Board was enthusiastic to see that the eight-year decline in enrollment ended in the Fall of 2022 when the College saw a slight increase in enrollment. The Board asked specifically about the 14% increase in military and veteran enrollments.
