3.6 Length of Terms of Board Members 1.) Members shall be appointed for a term of four (4) years. No person having served on the college board for two successive four-year terms shall be eligible for reappointment to the college board for two years. However, a person appointed to fill an unexpired term may be reappointed for two additional four-year terms. 2.) In accordance with policy of the State Board for Community Colleges, the anniversary date for members of the Board is July 1.
